TITLE IX..

Prohibits a school from discriminating against a student based on the student's pregnancy, childbirth, false pregnancy, termination of pregnancy; or recovery from any of these conditions.

TITLE IX ALSO..

Prohibits a school from applying any rule related to a student's parental, family, or marital status that treats students differently based on their sex.

ADJUSTMENTS & ASSISTANCE
