ADJUSTMENTS & ASSISTANCE

HARASSMENT & DISCRIMINATION

Title IX of the Education Amendments of 1972 prohibits discrimination based on sex in educational programs. This includes discrimination and harassment of students because of pregnancy or related conditions.
